

PRIVACY POLICY

AHAD welcomes you to its website and looks forward to a meaningful interaction.

This privacy policy, (hereinafter referred to as “the policy”) discloses the privacy practices we follow, here at AHAD. We do not disclose your personal information to third parties for their marketing purposes, without your explicit consent. AHAD respects the privacy of its customers (hereinafter referred to as “the User”) and understands their concern about the same. Please read this policy carefully to learn more about the ways in which we use and protect your personal information. The User hereby acknowledges that he/she/others has/have read, understood and agrees to be bound by all the terms of this policy and our website’s terms of use before he/she/others proceeds/proceed.

Personal information we collect from the User

AHAD collects and uses relevant personal information of Users, in order to provide a safe, efficient, smooth and customized experience. To use our site, you will need to register using our online registration form, where you may be required to provide us with your contact and identity information and other personal information, as indicated on the forms throughout the site. Our use of your information

We use your personal information to facilitate the services you request. The information provided by you allows us to determine your service requirements precisely and cater to them appropriately. The Users may however rest assured that such information pertains to that which is essential and relevant for providing our services. To secure your online

We will not share your personal information with advertisers; we will only share relating to the traffic on our website.

How the company transfers data to third party companies

AHAD does not submit User information to third parties except in the following cases:

- AHAD receives permission from the User.
- On outsourcing activities, wherein AHAD ensures that strict management of the information is enforced through a separately executed non-disclosure agreement.
- Disclosure of information in order to comply with the law or a court order;
- On sharing of information in a Business Transfer i.e. in case of a merger with, or acquisition by another company.
- In good faith, so as to protect the property of AHAD, or to protect the safety of employees and their families.

Cookies

AHAD stores cookies on the User's computer in order to facilitate and customize the experience with the Website.
